Having received various inquiries regarding the specific responsibilities of landowners and of the Association with respect to property maintenance and drainage and having reviewed the relevant governing documents of the Association on such matters, the Board hereby resolves that:

- The Association is expressly responsible for maintenance of drainage systems for Ashcroft common areas and roads, with the exception of those roads that are the responsibility of the Virginia Department of Transportation (e.g. Lego Road up to the traffic circle);
- The Association is not responsible for maintenance of drainage systems on the easements along the boundaries of residential

- lots unless declarations or other documents (e.g. property plat, etc.) specific to an individual lot or group of lots expressly impose such responsibility on the Association.
- The Association may, in its sole discretion, choose to address a drainage easement issue affecting a group of residential lots, and may further determine whether such costs should be recovered by general assessments on the membership of the Association.
