- 3. Comments, Questions from the Floor
  - a. Payroll money wise was not responsive; another payroll provider has been determined
  - LLC Kim asked if the lifeguards would be her employees; Ted clarified yes they would; Kim confirmed she would need general liability insurance to cover her/LLC in case of an accident
  - c. Amy asked about the option of Kim being an employee of Ashcroft; Ted noted that at the size of our entity, it's not efficient or feasible for us to operate as a business with employees
  - d. Kim confirmed she will create an LLC and get the necessary insurance - it just might take a few weeks to get the details sorted out
  - e. Rick questioned if Kim would anticipate shifting her costs based on findings on legal and insurance costs; Kim responded that would be possible, but also noted her staffing costs ranged based on our needs and she projected hire than probably necessary on chemical costs; anticipates that her personal cost would be on the higher end of her \$12-\$15K range
  - f. Ted asked about potential increase of salaries; Kim thought \$14/hr was a comparable range; Denise noted that recruiting kids in the neighborhood would also make it a very attractive
