Update on Outstanding Issues

- 1. ARC Bill Snow to provide list of recommended changes to guidelines. Will meet on April 4 to discuss list and begin re-writing.
- 2. Fob Reactivations 93 of 110 fobs were reactivated.
- 3. Dedicated Reserve Account we are collecting information from RPI and Rick Beyer to determine how much should be transferred from the main reserve account to the dedicated reserve account, and to establish controls to assure proper crediting in the future.
- 4. Insurance Ted is working with State Farm on obtaining non-monetary coverage. State Farm initially denied coverage, but is reconsidering their decision.
